WHICH PERSONAL DATA WE COLLECT AND FURTHER PROCESS?

You can unsubscribe anytime with clicking the "unsubscribe" button in your email or by contacting us directly at Groupcom@semperitgroup.com and ask to be unsubscribed from the mailing list. Appropriate action shall be taken within a week of receiving the request.

HOW DO WE PROTECT AND SAFEGUARD YOUR PERSONAL DATA?

In order to protect your personal data, we have put in place a number of technical and organizational measures which we ask our contractors to follow as well. Access to your personal data is provided to the responsible Semperit staff and to the external contractor CleverReach GmbH & Co. KG owning the website and engaged in maintenance, management and distributing newsletters on "need to know" principle. The data you provide will be stored on CleverReach's servers in Germany or within the EU (their <u>Privacy Policy</u>).

The information we collect will not be given to any third party, except to the extent and for the purpose we may be required to do so by law. We do not perform automated decision-making or profiling.

WHAT ARE YOUR RIGHTS AND HOW CAN YOU EXERCISE THEM?
